#### **DIRECTOR'S REPORT**

An art workshop grant is in the application process.

Workers Comp is increasing by 21% for 3 years due to a large claim. A safety audit reported no problem for the Library & no recommendations.

NYSLRS is under budget this year.

**OLD BUSINESS:** The heat pump contractor is working with the Library to use the Grant money received to cover Phase 1 of the project & the Library can spend matching funds before the Grant 2 eligibility period in July. All money spent works toward the Grant 2.

**MOU:** Referred to the Administration Committee. After their review it will be forwarded to the Service Committee for their perspective.

**NEW BUSINESS:** Mr. Mccann, Ms. Giugno & Mr. West have volunteered to serve as the Nominating Committee.
